Bagi Entiti Perniagaan yang **TIDAK BEROPERASI ATAU TELAH DITUTUP** sejak 30 Oktober 2024, Tuan/Puan hanya **PERLU** mengemaskini status Entiti Perniagaan Tuan/Puan di dalam Business Reporting System (BRS) **Section 3 – Business Status** dan pilih **NOT ACTIVE**.

Sukacita juga dimaklumkan, mengikut peruntukan Akta Maklumat Banci Pekerjaan 1974, **tarikh tutup penghantaran maklumat Banci ke sistem berkenaan adalah pada 30 November 2024**. Oleh yang demikian, maklumat Banci yang dihantar selepas tarikh tersebut akan dikategorikan sebagai penghantaran **LEWAT**.

Bersama ini sukacita dilampirkan surat makluman untuk rujukan Tuan/Puan.

Please note, in accordance with the Employment Information Act 1974, the deadline for submission is 30 November 2024. Submissions made after this date will be categorised as *LATE submissions*.
